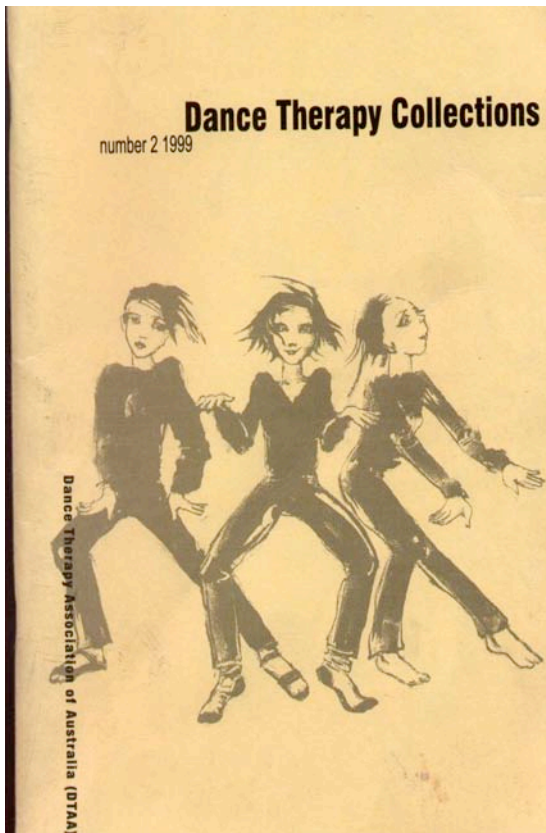


DANCE THERAPY COLLECTIONS 2
